**NOTIFICATION**

*Dated, Aizawl the 4<sup>th</sup> July, 2017.*

Whereas a situation has arisen where 6 (six) Executive Members of the Chakma Autonomous District Council, out of 8 (eight) have tendered their resignation, thereby making the Executive Committee non functional. Also 12 (twelve) District Council Members out of 20 (twenty) have proposed No confidence in the present Chief Executive Member, recommending a new Chief Executive Member.

Therefore, the Chairman of the District Council will take immediate action as per Rule 22 read with Rule 25 of the Chakma Autonomous District Council (Constitution, Conduct of Business etc.) Rules, 2002, to ensure that the choice of the District Council is upheld.

Therefore, the Governor of Mizoram, in exercise of the powers conferred by para 16 (2) read with para 20 BB of the Sixth Schedule to the Constitution of India, is pleased to assume all or any of the powers and functions of the Chakma Autonomous District Council and appoint the Deputy Commissioner, Lawngtlai as a Caretaker of the Chakma Autonomous District Council to exercise such powers and functions vested in or exercisable by the District Council with immediate effect and ensure that there is a free and fair floor test of the Chakma Autonomous District Council within a week from the date of issue of this order.
