NOTIFICATION

Dated Aizawl, the 14th February, 2025

In exercise of the powers conferred under Article 243K of the Constitution of India read with sub-section (7) of Section 3 of The Chakma Autonomous District Council (Village Councils) Act, 2002 as amended, the State Election Commission, Mizoram has issued Model Code of Conduct for General Election to Village Councils under Chakma Autonomous District Council, 2025 which has come into operation w.e.f. 14th February, 2025 and the same shall remain in force till Completion of the Election process.

The Commission further orders that -

- (1) No recruitment/appointment process in Government Departments/Public Undertakings/Corporations should be initiated or made which invariably includes written test, personal interview and selection of candidates involving candidates belonging to Village Council Constituencies within Chakma Autonomous District Council area excepting cases dealt with by the State Public Service Commission, without the prior clearance of the State Election Commission.
- (2) No transfer and posting in respect of officers/officials belonging to Village Council Constituencies within Chakma Autonomous District Council and officers/officials likely to be drafted for election duty should be made during the operation of the Model Code of Conduct. In the case of transfer orders already issued prior to the date of announcement of General Election to Village Councils under Chakma Autonomous District Council, 2025 but not implemented till the time when the Model Code of Conduct came into effect, should not be given effect to without obtaining specific written permission from the State Election Commission.
- (3) In such case where transfer of an officer/official is considered necessary on account of administrative exigencies, the department concerned, with full justification should approach the Commission for prior clearance.

All Administrative Departments are expected to cooperate with the State Election Commission in its onerous duties of conducting free and fair General Election to Village Councils under Chakma Autonomous District Council, 2025. Violation of any of the above will be seriously viewed by the State Election Commission.

NOTIFICATION

Dated Aizawl, the 14th February, 2025

Whereas, the State Election Commission, Mizoram has prescribed the Model Code of Conduct for observance by political parties, candidates and persons holding high public offices for the ensuing General Election to Village Councils under Chakma Autonomous District Council, 2025; and

Whereas, the Commission feels that there has been necessity for imposing restrictions on the activities of the Government servants during enforcement of Model Code of Conduct, i.e. from the date of announcement of election till completion of the process of election i.e. 18.03.2025.

Now, therefore, in exercise of the powers conferred under Article 243K of the Constitution of India read with sub-section (7) of Section 3 of The Chakma Autonomous District Council (Village Councils) Act, 2002 as amended, the Commission hereby orders that a Government servant holding office in State Government, Autonomous District Council, Central Government, Public Sector Enterprise of State or Central Government, Statutory Bodies getting financial assistance from the Government within the CADC area will come under the purview of the Code of Conduct for observance by the Government servants as follows:-

- (1) A Government servant shall remain absolutely impartial during the election and he/she shall not indulge in any campaigning activities for or against any contesting candidate or political party;
- (2) No Government servant shall subscribe in aid of, or assist in any way, any candidate;
- (3) The Government servant shall not himself speak at or take active and prominent part in organizing or conducting the meeting;
- (4) No Government servant should accompany a Minister/Chief Executive Member/Executive Member/ Member of District Council or such other political functionaries for electioneering;
- (5) No Government servant should attend any political meeting except those who are in-charge of maintenance of law and order or those deployed for security duties;
- (6) Police personnel engaged in law and order duties shall not be construed as participating in the meeting of any candidate;
- (7) While dealing with different political parties in day to day official transaction each Government servant shall maintain absolute neutrality. While registering cases on complaint filed by different political groups or contesting candidates or their supporters, police will take prompt steps in most impartial manner;
- (8) Violation of Code of Conduct by any Government servant will make himself/herself liable to disciplinary proceeding under the provisions of the Central Civil Services (Classification, Control and Appeal) Rules, 1965.
