- > To work in collaboration with Non Governmental Organisation (Ngo) such as CYCA, CMS,MCSU,etc as far as possible to meet the objective.
- > To make effort in fullfillment of Departments objective as, when and where necessary.

#### Power and duties of officer and employees:

- > The Art & Culture Officer executes the decision of the executive committee of CADC with the assistance of the subordinate Officer and Staff.
- > The Sr. Research Officer conducts research on Chakma language, Script, Custom and Tradition etc. with the help of Research Officer and staff.
