About:

Public Health Engineering Department is one of the various departments of Chakma Autonomous District Council whose purpose is basically for water supply and sanitary scheme. It serves through various means of Schemes like construction of water reservoir in remote areas, construction of public toilet where it is necessary, construction of ring well, and rain water harvesting tank etc.

It is headed by the Executive Engineer of Public Health Engineering Department. He is supported by an Assistant Engineer, Sectional Assistant and some clerks.

Function & Duties:

- Construction of Water reservoir.
- Construction of Public Toilet.

- Construction of urinals.
- Construction of rain water harvesting tank.

Power & duties of Officers and employees:

The Executive Engineer/officer executes the decision of the Executive Committee of CADC on any matters with the assistance of its subordinate staff.
